One more time and thanks everyone for your patience. I want to make sure we have language right that will correct some of the outliers and should also reduce concern among our members.

Representative Bedey, we would appreciate it if you could let us discuss and ensure common ground before approaching Senator Salomon regarding possible amendments. Please see the attached. These amendments do two things:

1. Page 3, Lines 1-4. On the suspension and expulsion of students seeking out of district attendance, I have reinstated the language that ensures that suspension and expulsion can be grounds for denial for any student, including a student qualified for services under IDEA. I have also amended the language regarding a suspension in the three years preceding requested enrollment and have amended it to one year (or the year in which attendance is sought, to address someone trying to move midyear after a suspension) as specifically requested by Disability Rights during the hearing. The following is the portion of the hearing where Disability Rights specifically said they would support the bill with an amendment limiting the impact of a suspension to no more than one year prior to requested enrollment:

2. Page 8, Lines 22-23. I have proposed to amend the rate of tuition so that 35.3% is a standard default, but which also ensures that the percentage of the tuition per-ANB amount is no greater than the percentage that general fund property taxes (BASE and Over BASE) represent as a share of the general fund budget in either the district of residence or the district of attendance. I have pasted a color coded alphabetical list of all school districts with the percentage of general fund budget represented by property taxes and identifying whether the result would be a cap at 35.3% or whether the tuition per ANB rate would be lower because of lower tax rates. This will specifically solve all the tuition issues in school districts with virtually no tax base and/or those with very small amounts of local taxes (such as Colstrip).

The Coalition is scheduled to discuss this further soon and we can get back to you with final thoughts before proceeding with a request of Senator Salomon to help amend the bill.

Subject: Possible Amendments to HB 203

Representative Bedey,

As you likely know, those of us partnering in the Coalition of Advocates for Montana's Public Schools have been receiving continued questions, concerns, comments, regarding House Bill 203. We are not sure that the concerns can be addressed but we want you to know that we will continue to support House Bill 203 but that we are also interested in working with you on amendments that might significantly reduce the angst among some of our members. We are hopeful you might give consideration to some amendments that would preserve the intent of the bill but also mitigate some of the tax concerns. We have heard from some districts with very low tax wealth and significant challenges with student achievement that are worried about having to spend impact aid funds.

Sort of the perfect storm in this regard is found in Lame Deer. Lame Deer reports that they have 100 resident students who attend school in Colstrip. The problem that they cite is that Lame Deer has no tax base, so they will be required to send general fund or impact aid funds to Colstrip. Colstrip actually has no BASE levy, being funded primarily by coal taxes.

We are hoping your will consider the following, which we have drafted into a grey bill that I have attached for your review.

- 1. Page 2, line 16, introduce the interests of taxpayers in the district of attendance as a factor the district of attendance can consider.
- 2. Page 3, new subsection (f) that allows denial when the tuition payment is insufficient to adequately mitigate the impact to local taxes in the district of attendance.

- 3. Page 3 Re-fix special ed suspensions and expulsions. Remove the blanket waiver and implement the "suspension in the immediate preceding fiscal year" as disability rights asked for during the hearing.
- 4. Page 8 Change the tuition payment to be calculated on BASE property taxes per ANB. This change needs to be considered in conjunction with the new language referenced in 1 and 2 above.

The formula for tuition would be the general fund property taxes per ANB of the district of residence but also capped at no more than the BASE property taxes of the district of attendance.

An example of the tuition calculation in practice:

Darby High School student seeks attendance at Stevensville High School

- 1. Darby general fund property taxes (BASE and Over BASE) per ANB = \$2,449
- 2. Hamilton general fund BASE property taxes per ANB = \$2,016
- 3. Tuition payment of Darby to Hamilton = \$2,016
- 4. Hamilton gets to consider, as part of its decision on whether to allow the Darby student to attend, whether the taxes of resident taxpayers have been sufficiently mitigated.

We think this change would reduce dissent among our members. It would also solve most of the outlier districts, predominantly American Indian, who have no tax base. We think these amendments would improve the bill while also upholding the intent of increasing public school choice and ensuring that tax money follows the student.

Maybe we could discuss tomorrow when I see you at 4 pm.
