- The MQEC Board of Directors consisting of several SAM member superintendents and associations are currently reviewing the District and Federal court rulings and preparing for appropriate action to protect the education provisions of the Montana Constitution as applied to the implementation of SB 410 (Tuition Tax Credit bill). Click HERE for more details. The Montana Supreme Court heard the Espinoza et al. v. Montana Department of Revenue case on April 6, 2018 in Missoula. On December 12, 2018, the Montana Supreme Court issued a favorable decision in Espinoza et al., finding 15-30-3111 MCA (the tax credit for donations to private schools) unconstitutional. - The SAM office transition and restructure 2019 is currently being implemented.
- YH Advisors (Brian Yacker, Partner), are working well with support for payroll, bookkeeping, and tax completion services this assists with our financial operation and with internal controls important to the viability of our finances. Currently working on 2017 Taxes for SAM and MASS.
- SAM continues implementation of association management software (MemberClicks) upgradng our website, database and tools for all SAM members. Web-based communication tools have been created for the use of our Members. E-Lists have been used as a notification tool in which responses are emailed to an entire affiliate.
