From Constitution: Terms of office for the President, President-Elect and Vice-president shall be for one year only. The State Coordinator's term shall be for three years, while the regional directors shall be for two years. Regions 1, 3 and 5 shall elect directors in odd numbered years. Regions 2, 4 and 6 will elect directors in even numbered years.

Regions I, III, V: Shall Elect Directors In Odd Numbered Years
Regions II, IV, VI: Shall Elect Directors in Even Numbered Years

Elections for statewide office shall be held at the annual spring meeting of the association
 Directors shall be nominated and elected in regional caucuses held prior to or during the October Conference of Educational Leadership. The results of each regional caucus will be reported at the business meeting during the October Conference. e. In case of a vacancy during the term of office, the office shall be filled by appointment of the Executive Board for the remainder of the term. Vacancies shall be filled from the region in which the vacancy occurred.

Officers - Term: Terms of office will begin immediately after election.
