MCASE BOARD MEETING: 2/19/2020

I. Welcome and Introductions – Michelle Halberg

President Michelle Halberg called the February 19, 2020 Board meeting to order at 5:40 PM

II. Consent Agenda: Minutes December 5, 2019 Board Meeting via "GoToMtg" (Motion/Discussion/Action)

Michelle reviewed the meeting minutes from December 5, 2019. Pam Pettigrew moved to approve the meeting minutes for December 5, 2019. Lisa Von Bergen seconded the motion. There was no discussion and the motion passed unanimously.

III. Budget-(Informational)

A. 2019-2020 Budget

1. Lori Ruffier Legacy Award- Recipient \$500

This award has been granted to a Flathead Speech Pathologist.

2. D.C. Legislative Summit- Tamra Covington/Sara Novak (Emilie Maule/alternate) -\$5,000 estimate with flight, rooms and per diem.

Tamra is unable to attend D.C. Legislative Summit this year (July 12-15, 2020). The Board discussed sending two individuals to attend the D.C. Legislative Summit with the use of an alternate. Emilie Maule and Sara Novak will potentially attend this year. There is an estimate of \$5,000 total for two participants. The D.C. Legislative Summit budget cost for July 2020 falls under the 2020-2021 budget. The Board added a motion to the agenda. Karen made a motion to send two MCASE members to the D.C. Legislative Summit for the 2020 summer and here forward. Tamra seconded this motion.

Board members discussed the needs for preparation to attend the D.C. Legislative Summit. Tamra gave her feedback on previous attendance and the requirements of participation. Kirk Miller recommended that collaboration with MASS takes place as they will have representatives at the D.C. Legislative Summit as well. Board members discussed aligning the role with CASE Unit Report language.

The motion passed unanimously.

B. 2020-2021 Budget going forward-

Michelle recommended that the budget changes below be approved at the MCASE Board Delegate Assembly and the presented at the Fall MCASE Conference to membership.

Michelle asked for clarification on the cost of the Evening of Excellence and the coverage of cost for award winners. Kirk Miller discussed that break down of cost for individuals. Board members discussed adding a budget line item to provide lodging at the site of the event for award winners to attend the Evening of Excellence. The projected cost of gifts and awards would be approximately \$1,300.

2. D.C. Legislative Summit – Send Two MCASE Representatives (2) \$4,500; Legislative Projected Line Item \$5,000

4. MCASE/MCEC Winter Joint Conference – Cost/Budget Impact to be determined

Michelle discussed having a stronger presence in the winter MCEC conference and a financial contribution to this conference. Michelle stated that a more formal statement through the leadership strand would be her recommendation. Kirk Miller discussed that SAM could help to develop the leadership strand. This addition would be an unknown to the budget and projections will take place this June.

Discussion took place regarding the discrepancy in MCASE membership compared to CASE. Board members discussed having a point person for recruitment in each region or overall for MCASE and the budget implications to have this person appointed.
