1. Call Meeting to order

2. Approval of Agenda [Action]

3. Approval of <u>Minutes META Membership Meeting 3-18-19</u> [Action]

4. President Report – Everett Holm

Everett Holm talked about the impact of COVID and the response from MT school districts stating that Montana showed lots of grit by getting the students taken care of with plenty of options for remote learning. The Student Data Privacy Agreement work has been strong and Montana continues to keep students safe from internet harm. He mentioned that Browning has had students trying to end their lives and the connections they made by monitoring internet activity and making sure students are safe. Mental health gets better when kids are back in the schools. Everett encouraged folks to stay in tune with the current Legislative Session and bills that impact public schools. He mentioned that Richard Lawrence has agreed to continue serving as the META Delegate Assembly Steering Committee Representative. Brian Norwood stated that the conference was a huge success. Very happy with the outcome.

5. <u>Executive Director Report – SAM Update</u> – Kirk Miller

Kirk Miller discussed the current state of META. The affiliate is 6 years old and making a difference. META has had a seat at the table and has become a very strong affiliate of SAM. The conference was a great method for discussing the issues that Montana Public Education is facing. META has a voice in the room so that they can continue to grow and make connections throughout the state. Kirk pointed out the SAM Update and the SAM Strategic Goals document. Kirk walked through the COVID document and let them know about the updates that have been made to this document. He referenced the 6 feet to 3 feet update that has come from the CDC. Kirk talked about the ESSER II and III appropriations. SAM and MT-PEC have put in a great amount of work in connection with ESSE funds. Lastly, Kirk stated that on March 4, MT-PEC reported out on the vaccination process for school personnel. Kirk also referenced the Legislative Session information. He mentioned that SAM will be keeping META up to date with the Call To Actions. Kirk discussed the SAM LPLP Program and success that it has had and the growth. Kirk is happy to serve as Executive Director. Work has been fulfilling.
