## October is Cybersecurity Month by Carol Phillips, METAPresident

As leaders in your school, you are challenged daily to manage the many priorities that come across your desk. One such priority, that you may have been seeing more of lately, is that of improving your cybersecurity posture. If your school's network and/or data is hacked it will be very hard to serve the students and staff in your district. Unfortunately, there are many nefarious characters in the world that are actively going after the educational sector within the state of Montana. In addition, cybersecurity premiums have become a multi-billion dollar industry. In fact, according to Schools' Insurance Costs Soaring - and Climate Change Isn't the Only Reason article from the Education Week

website in June 2023<sup>1</sup>, the cost of cybersecurity insurance in schools has gone up across the nation approximately 328% in two years! You may have already seen some network security surveys that need to be completed from your insurance carriers. Since October is Cybersecurity Awareness month it is a great opportunity to sit down with your Technologist, if you have one, and review what your current cybersecurity situation is. It is also a great month to take a moment to educate your staff, students, and community about cybersecurity and what they can do to protect themselves, and the school district.

Let's start with Cybersecurity Awareness Month created by the Cybersecurity and Infrastructure Agency (CISA) and the National Cybersecurity Alliance. They have many great free resources to share with your students, staff and community. You can learn more at Cybersecurity Awareness Month. There are articles as to why password complexity is important, phishing emails, updating software, etc. You can sign up to be a Champion of Cybersecurity and they will provide a FREE social media kit with premade graphics, and articles that you can share during the month of October. Since cybercriminals often use social engineering tactics this is a great place to start to improve your cybersecurity stance.

The next part of awareness is acknowledging exactly what your current situation is. This will allow you to decide what areas you need to work on. To do this you can fill out, with your Technologist, a Network Security Survey or other evaluation tool. You can get these tools from your insurance carrier (i.e. MSGIA, Payne, etc) or online. For example, CISA has an entire K-12 Security Guide Product Suite that is free for schools to use. Take a moment to evaluate yourself in October. Some guides will give you a score or a grade. Just like in school, when you receive a lower score than you hoped for, you just need to work a little harder to improve and earn that gold star. Make a commitment to spend a little time each month during this school year to improve on weaknesses that you uncover. Pretty soon, your score will be higher and you can wear that gold star with pride!

You could also leverage your insurance carrier resources for training, knowledge, and opportunities to improve. It is in their best interests to assist you, and your team, in making improvements to the cybersecurity structure within your district. Start by asking your Technologist to reach out to your insurance representative and learn about the best first steps in a Data Breach Incident Response Plan.

Another great step is to take a moment to make sure your Technologist is a member of the Montana Educational Technologists Association (META). Becoming a member of META offers many benefits:

## Embracing Generative AI in Education: A Cautionary Path.

In the rapidly evolving landscape of education, technology continues to play an increasingly vital role. One of the latest advancements on our radar is Generative Artificial Intelligence (AI), a tool that has the potential to reshape the way we teach and learn. While the possibilities are exciting, it is crucial for us, as educational leaders, to approach this technology with caution while recognizing its potential as a powerful learning tool.

SAM recently hosted Jason Neiffer for our monthly webinar series. If you have not had a chance to listen to <u>Jason's presentation about Generative AI</u> - I would encourage you to do so. It will give you a great overview of what is currently happening with this technology.

Generative AI can generate human-like text, answer questions, and even assist with tasks such as content creation. These capabilities present exciting opportunities, from personalized learning experiences to enhanced teacher support. However, embracing generative AI requires a delicate balance. For example, many educators are concerned that this new technology will make it easier for students to escape difficult work, like writing.

With this technology moving faster than many of us have predicted, it has created some "knee-jerk" reactions from schools across the country. Last spring, many districts made moves to ban the technology in their classrooms. Others have stated that they will use resources to "detect" the use of AI in student work. For our school administrators, I would recommend a cautious approach, rather than the heavy handed discipline approach for teachers and students.

In late August, I had the opportunity to discuss this issue with a national expert Victor Karar, the CEO of <u>Scrible</u>. His company has many years of experience in helping students and teachers with the writing process.

I asked specifically what school leaders should avoid with regards to policy and practice. Below is a short list of recommendations from Victor.

- Don't take the "ban it" or "block it at school" approach. The effort is likely futile and you will end up changing course in the coming months as the technology is evolving so quickly. In addition, students can access the technology outside of the school network. This means you will create inequalities with regard to who is actually impacted by your practice of banning or blocking.
- Don't assume that we should stop teaching writing. Sure, AI could produce a decently written document that could be submitted for credit by a student. However, the writing process builds critical thinking skills. Every student should experience this process, even if it is easier and faster to do it with AI. Encourage your teachers to teach writing much like their approach to teaching math "show your work." Students should be showing their effort in each step of the writing process, not just the final product.

on an assignment. You may have someone tell you that products like Turnitin or GPTZero can
detect when students are using AI to write their paper. In his research, Victor discovered that
several of these AI detectors have shown a high % of false positives, between a 20-50%
occurrence rate. That means you may be falsely accusing a student of using AI, when actually
they did author their own paper. Something to keep in mind before we discipline a student for
cheating with AI.

Finally, we must remain adaptable. The field of AI is rapidly evolving, and what we know today may be outdated tomorrow. It is crucial to maintain a growth mindset, embracing change while critically assessing its impact on our educational goals.
