I hope things are going well for you as most of the districts are heading back to school or are already back. I can't believe that I am actually writing to you from home and I have been home for an entire week. I could get comfortable spending some time at home for once.

I am following up with you on our discussion of Gabbart providing a newly updated (obviously ADA compliant) website for SAM. In most situations where we are in this type of agreement, we will do it as an exchange for group membership, conference booths, speaking opportunities, etc. I believe if we were able to work out an exchange with SAM, the Montana Mountain Sponsor level would be a perfect fit.

In addition to a Gabbart website, we would also include our E-Notes Pro mass notification system. This would allow anyone with the SAM organization to send unlimited texts and emails to any variety of customizable call lists. For example, the META group could create call lists for all members and send out group texts or emails, or they could create call lists for specific members (maybe Tech Directors only) and message them accordingly. Obviously, the leadership team of SAM would be able to do all of those same things.
