2. SAM Update - Rob Watson

- a. HB676 and active consent for SLP hearing screenings at member school districts
 - i. Parent's rights bill
- b. HB203 impacts special education funding within a cooperative model
 - i. District being reimbursed beyond child count-does the money flow to the CoOp? Rob-money flows to the district and it is dependent on the agreement between the district and CoOp. The District could reduce the funding to the CoOp depending on the funding agreement. ANB goes to the serving District.

- ii. Out of attendance areas CoOps can become confusing.
- c. February 22nd Monthly SAM Webinar at 10:00.
 - i. Focus on the open enrollment bill. Providing guidance on policy updates on open enrollment.
- d. HB890-school boards required to record their meetings
- e. March 11-12 in Helena at Great Northern Hotel combo conference with MASS and META-legal issues and technology. The Dept. of ED will have a FERPA update and someone from Bea Kaleva's office will present. Business meeting for MCASE will be held as well.
- f. Starting the Early Literacy Programs as well as the Jump Start over the summer. How do they work with the ESY and Sped PK programs? They should cross over and students should not be eliminated from programs because they are in one of the other programs.

- g. Update on School Psychologist out of state licensure
 - SAM advocated for a change for the certification of School Psychologists licensure -Rule 10-57-434 (How school psychologists are certified when transferring between states)
 - ii. OPI can certify without going through the U of M. This rule change has to go through public comment on March 5th. Open for public comment via email up to March 5th and then can be in person on March 5th.
 - iii. This is a change for anyone getting the license/endorsement. Class 6 License for those who do not have an educator's background such as School Psychologists and Counselors.
 - iv. Licensure costs increase for everyone.
