- The MQEC Board of Directors consisting of several SAM member superintendents and associations are currently reviewing the District and Federal court rulings and preparing for appropriate action to protect the education provisions of the Montana Constitution as applied to the implementation of SB 410 (Tuition Tax Credit bill). Click <a href="HERE">HERE</a> for more details. The Montana Supreme Court heard the <a href="Espinoza et al. v. Montana Department of Revenue">Espinoza et al. v. Montana Department of Revenue</a> case on April 6, 2018 in Missoula. On December 12, 2018, the Montana Supreme Court issued a favorable decision in Espinoza et al., finding <a href="15-30-3111 MCA">15-30-3111 MCA</a> (the tax credit for donations to private schools) unconstitutional.
