The results of the great work of 45 delegates, assembled for SAM Delegate Assembly 2019 (SAM DA 19) on June 13-14, are compiled, organized and prepared for review of the SAM membership. First, I want to thank the Delegates who participated in the very engaging and important discussions that happened at SAM DA 19. Your work in advocacy is so important to help create priorities for the 2021 legislative session and federal issues. [SAM DA 2019 Business Meeting Recommendations 10-18-19](#) is the document outlining SAM Advocacy Priorities by Action Designation, Summary of SAM DA Actions, DRAFT DA Minutes, Positions, and Resolutions adopted by the SAM DA 19. The recommendations created will be considered by the entire SAM membership at the annual SAM Business Meeting on October 18 at MCEL in Billings at the Northern Hotel, Ballroom North from 8:30 to 10:30 AM. We hope you will attend this meeting and take action on SAM's advocacy priorities, positions and resolutions!

Also, at [MCEL 2019](#) (October 16-18) in Billings, you can expect to receive the release of GREAT VII 2019 (The Great Work of Montana's Public Schools, Volume VII, 2019)! The partners of MT-PEC (Montana Public Education Center) administer the annual opinion poll of Montana voter's perspectives on K-12 education issues, leading to a refocused strategic plan of the K-12 Vision Group describing the significant progress made as a result of our collective efforts to meet the Constitutional guarantee to develop the full education potential of each person. GREAT VII will be a very important resource for you and your community when considering the support for the education of the kids in your community.

Professional Learning and Services

The partners of MT-PEC (Montana Public Education Center) have recently collaborated in developing a unified plan for the professional development of our members on key topics related to funding, flexibility, efficiency, safety and security, community ownership and local control. Our goal is to ensure a broad and common understanding of the full extent of the obligations and authority granted to Montana's public schools in these areas, and to contribute to a body of knowledge that we believe will enhance our members' abilities to develop the full potential of each child in every public school in Montana. We have developed a [FRAMEWORK](#) for this year long professional development series that will be launched at [MCEL 2019](#) with live streamed sessions on Wednesday afternoon, October 16 and all day, following the opening keynote, on Thursday, October 17.

By the way, the keynote presentation on Thursday morning will provide you with great ideas for engaging your community in support of your schools. Jamie Vollmer, author of the "The Great Conversation" and "Schools Cannot Do It Alone", is coming to Montana to share these ideas with us at [MCEL 2019](#).



Student Data Privacy

The Consortium for School Networking (CoSN) and its state affiliate chapter, [Montana Educational Technologists Association \(META\)](#) are pleased to continue to support the work of current and aspiring superintendents and district leadership teams in leading all aspects of digital learning transformations.

Last month we began the new school year by taking a look at the [CoSN Empowered Superintendent Initiative](#) and the [CoSN Driving K-12 Innovation Report](#). This month we turn our attention to the ever-critical issue of student data privacy.

As school leaders continue to grow in their knowledge and expertise in using data to drive instruction and other multiple facets of school operations, the issue of leading and managing student data privacy can sometimes seem confusing and even overwhelming. CoSN is pleased to share a one-page critical issues document that covers the five critical guidelines for ensuring data privacy in your district's or school's use of technology, available at this link: [Student Data Privacy](#).

To assist school leaders in assuring all stakeholders that their district has built a system and culture of trust and transparency with regard to student data, CoSN developed a comprehensive process for school districts to earn the [Trusted Learning Environment \(TLE\) Seal](#). Montana school technology leaders have proven to be trailblazers in this work across the state through the formation of the SAM Leaders Professional Learning Program Trusted Learning Environment Collegial Learning Network (SAM LPLP TLE CLN). The TLE CLN, which is the first such cohort in the United States, allows districts to work together to update and strengthen their data privacy practices. A year ago, Bozeman Public Schools became one of 16 school districts in the country to earn the TLE



Seal. Through the work of the SAM LPLP TLE CLN, eight other Montana school districts are on the path to earning TLE Seals. Learn more about how and why the TLE Seal can support your data privacy work by clicking [HERE](#).
