#### Resolution #16-01 ONLINE VERIFICATION AND GRACE PERIOD FOR REGISTERING EDUCATOR LICENSE

WHEREAS, educators must register their certificates within 60 calendar days of performing contracted services per MCA 20-4-202; and

WHEREAS, only the original certificate can be registered; and

WHEREAS, MCA 20-4-202 does not allow a grace period to address registering certificates with a County Superintendent of Schools Office; and

WHEREAS, it has become difficult to register certificates with a County Superintendent of Schools Office within the 60 calendar day period either through part time office hours or licensure issues;

BE IT RESOLVED, that SAM supports legislative action to add the option to allow a grace period in registering the original certificate with consistent access to County Superintendent of Schools for online verification of certificate registration through scanning and submitting through email or digital affidavit from the TEAMS/FTE Report up to the December 1 teacher assignment deadline.

#### **Supporting Information**

While there is no fiscal impact to SAM resolution #16-01, I argue that it is an unnecessary focus for the School Administrators of Montana's lobbying efforts. It should not be an action item or a support item. Rather, it should not be a resolution at all.

True, MCA 20-4-202 is outdated now that MSIS exists. When this statute was written, there was no electronic method of determining if a teacher was properly licensed. Thus, a better effort might be to abolish the requirement to register the certificates at all and require the school clerks to identify whose license is expiring or that new staff are properly licensed. All this information is available online. However, the County Superintendent provides a service to county schools by generating lists of teachers whose licenses will expire at the end of the school year. This provides for a system of checks and balances that keeps teachers from slipping through the cracks, resulting in licensure issues being picked up when completing the TEAMS report where it will result in an accreditation problem and decrease in the quality educator payment.

The fact that some County Superintendents hold part time positions is no barrier to getting the original license processed in a timely manner. OPI turns around license renewals within a week, and teachers no longer have to send in their renewal units or transcripts in order for the license to be processed. 5 years is more than enough time to get the necessary renewal units or university credits to renew a license—no extension is necessary. For teachers new to the field graduating from Montana universities, their university personnel assist in the initial licensure processing and most are duly licensed by the end of summer. For those seeking provisional licenses or additional endorsements, the time necessary to receive official transcripts and submit to OPI is no more than two weeks. Thus, 60 days is more than

enough time to accomplish this. Finally, professional licenses (OT, PT, SLP) must be renewed yearly and can be done via email. These individuals don't get an original license, just a print out. They can email the county superintendent a print out, and she can can print it and send it back in the mail.

There is nothing in statute that requires an individual to come in person to register a license. They can be left in a locked drop box or sent to the county superintendent in the mail. She can then send it back to the individual, and the process can be completed within a few business days regardless of how part time the officeholder. If a license is lost in the mail, the OPI can replace it within days.

As County Superintendent in a large county, my experience has been that those who miss the November 1 deadline have failed to accrue the required 60 renewal units or university credits. They either lost their paperwork or simply didn't take the required courses. Since university credits are no longer required for renewal, the process to get a renewal license has gotten so easy that there is no excuse for missing the November 1 deadline. Unprofessional behavior should not be rewarded with a grace period.

# Montana Code Annotated 2015

**20-4-202. Teacher and specialist certification registration.** (1) Any person employed as a teacher, specialist, principal, or district superintendent shall register the person's certificate or the district shall register its emergency authorization of employment for a teacher with the county superintendent of the county in which the person is employed in order to validate the person's employment status and permit payment under the employment contract. If a teacher or specialist does not register the person's certificate with the county superintendent within 60 calendar days after the person begins to perform services, the person is not eligible to receive any further compensation under the contract of employment until the person has registered the certificate . After the schools of a district have been open for 60 calendar days in the current school fiscal year, the county superintendent shall notify each district of the county of each teacher or specialist who has registered a current valid certificate, and the district may not pay any teacher who has not registered the person's certificate until the county superintendent does notify the district of the registration.

(2) A teacher or specialist employed by a joint district shall register the person's certificate with the county superintendent of the county in which the person is working. A teacher or specialist employed by a special education cooperative shall register the person's certificate with the county superintendent of the county in which the special education cooperative is based.

WHEREAS, SAM believes there is no single measurement evaluating the quality of education between students and schools; and

WHEREAS, SAM believes any mandated programs of testing must be fully funded and include fully funded researchbased intervention programs that help students reach benchmarks; and

WHEREAS, SAM believes that the current concept of high stakes testing does not help schools meet the needs of its students or its community;

WHEREAS, SAM believes that federal and state mandated testing and reporting are excessive and the time required for testing needs to be balanced with time for student instruction;

WHEREAS, SAM believes that using computer adaptive testing is valuable and technology should work appropriately to insure students have the best opportunity to reflect what they know and are able to do during testing in order to have reliable and valid results;

BE IT RESOLVED, that SAM supports use of multiple measures of school assessment in local school improvement projects; and

#### Resolution #18-01 – ALLOWING THE USE OF PERMISSIVE MAJOR MAINTENANCE SUBFUND OF THE BUILDING RESERVE TO SECURE AND REPAY LOANS

**WHEREAS,** Montana's students have the right to high quality, safe, healthy and educationally appropriate educational facilities that meet the needs of 21<sup>st</sup> Century learners; and

WHEREAS, Montana's school systems have a well documented backlog of deferred maintenance and other facility needs; and

WHEREAS, SAM has worked with the Legislature to expand funding for capital facilities needs across the state; and

**WHEREAS**, the 2017 Legislature provided school districts with an additional tool via MCA 20-9-520 (3) allowing local school districts to permissively levy up to 10 mills into a Major Maintenance subfund of the Building Reserve; and

WHEREAS, due to the many years of deferred maintenance many district's have major maintenance projects that exceed the yearly funding available in the Major Maintenance subfund of the Building Reserve; and

WHEREAS, construction and repair costs for these projects tend to increase over time; and

**WHEREAS**, current law, MCA 20-9-503 (2) still requires the electors of the district to authorize projects and financial impositions in order to secure a loan;

#### Support Information

The 2017 legislature addressed the well documented under funding of Montana school facilities by passing SB307.

This change to the law allows districts to permissively levy funds for their Building Reserve. These funds will allow districts to address major maintenance projects, which have built up over the years. This funding is limited to the lesser of: 10 mills or \$15,000 per district plus \$100 per ANB. While this additional earmarked funding is certainly appreciated, many districts have longstanding needs; the money in this fund will need to accumulate for several years before they can address said needs.

The purpose of this resolution is to remove language in law preventing districts from using this permissive fund to secure a loan to address their needs. By allowing districts this flexibility to leverage their permissive authority to borrow funds, it allows school boards to address facility needs sooner and saves the state money by having work done at current rates.

#### **Resolution #18-02 – SCHOOL SAFETY**

WHEREAS, school shootings and school violence are occurring at increasing rates in our school communities across the nation; and

**WHEREAS**, Montana law currently provides for local control allowing a Board of Trustees to decide who may possess a firearm or other weapon in a local school district; and

**WHEREAS**, school teachers, staff, administrators or others in possession of a firearm on school property requires significant and ongoing training for proper use and safety of firearms; and

**WHEREAS**, some Montana school districts and communities are located at significant time and distance from local law enforcement support and armed law enforcement officers; and

**WHEREAS**, the focus of our schools, teachers, staff, and administrators should be on quality teaching and learning;

**BE IT RESOLVED**, that SAM opposes possession of weapons on school property by school teachers, staff, administrators, or any other persons except as authorized by a local Board of Trustees; and

# **Resolution #16/17-06 – ADDITIONAL FUNDING FOR CAREER AND VOCATIONAL/TECHNICAL EDUCATION**

**WHEREAS**, funding for Career and Vocational/Technical Education (CTE) in Montana is well below the funding levels for programs in neighboring and other western states; and

WHEREAS, establishing an ongoing funding mechanism for middle school career and technical education makes minimal resources available for middle school level career and technical education offerings; and

**BE IT RESOLVED**, that SAM will primarily support legislative action targeting additional funding for HS CTE programs including inflationary increases; and

**BE IT FURTHER RESOLVED**, that SAM will support legislative action to create a funding mechanism to provide career and technical education opportunities for students in accredited middle schools that supplements but does not supplant high school funding.
