
SAM Executive Director Evaluation 2017 Executive Summary

2. RELATIONSHIP WITH BOARD




Comments on Relationship with Board

 great advice.


3. RELATIONSHIP WITH MEMBERS

- Our members have great respect for Kirk.


4. PUBLIC RELATIONS

- Kirk works hard to promote the core values and to lobby for important issues for education.


5. RELATIONSHIP WITH AFFILIATES
