Kirk also referenced the SAM AI Profit-Loss Historical FY 2015-16 to FY 2018-19 noting that the difference in revenue is caused by changes in attendance. Kirk referenced the SAM LPLP FY 13-14 through FY 18-19 Profit-Loss noting that some revenue is still due from the MSU Department of Education for the Title II grant. Kirk also referenced the projected revenue and expenditures for FY 2018-19. Kirk referenced the Business Partners 2018-

19 by Sponsorship Level 10-18-18 pointing out the service agreements in place from Lightspeed and MT ASCD create revenue to SAM, and the in-kind sponsor, ICLE, provides speakers.
