On behalf of Secretary Cardona and Deputy Secretary Marten, thank you for participating in the Regional Superintendent Roundtable last Friday, January 28. We are committed to ensuring the U.S. Department of Education is a service agency, and conversations with you and superintendents across the country help us better understand the needs of students, educators and schools. We are grateful for your time and open and honest dialogue. Your job has never been easy, but the past two years (and counting!) have put you to the test. We appreciate everything you are doing to keep everyone safe, while helping students learn, grow and thrive.

As a follow up to the conversation, we wanted to share links to several of the resources that were mentioned:

1. COVID-19 Testing
